

# QATAR AIRWAYS AUSTRALIAN MOTORCYCLE GRAND PRIX 2024

## EVENT PARKING CONDITIONS

**IF YOU DO NOT ACCEPT THESE CONDITIONS, YOU MUST NOT ENTER THE PARKING AREA AND/OR YOU MUST IMMEDIATELY LEAVE THE PARKING AREA. BY ENTERING THE PARKING AREA AND/OR PARKING YOUR VEHICLE IN THE PARKING AREA, YOU WILL BE DEEMED TO HAVE ACCEPTED THESE CONDITIONS, INCLUDING THE RELEASE IN CONDITION 10 AND THE INDEMNITY IN CONDITION 11.**

You and your Vehicle's entry to and presence at any parking area at the Australian Motorcycle Grand Prix event (as defined in the *Australian Grands Prix Act 1994 (Vic)*) (**Event**) is subject to the following conditions and the Event's Attendance Conditions (available at [www.motogp.com.au](http://www.motogp.com.au)) (together, the **Parking Conditions**):

1. You enter the parking areas at the Event at your own risk. You are responsible for the safety and security of yourself, your passengers, your Vehicle and your personal property.
2. If the Australian Grand Prix Corporation (**AGPC**) or Dorna Sports S.L. have granted you an authorisation or accreditation for your Vehicle (**Vehicle Accreditation**), you must clearly display the Vehicle Accreditation on your Vehicle at all times during the Event. No Vehicle may be parked in a reserved parking area without displaying the relevant Vehicle Accreditation.
3. If you have purchased a parking ticket to park your Vehicle at the Event (**Parking Ticket**), or a public storage ticket to store your property (such as a helmet) (**Public Storage Ticket**), you must retain your Parking Ticket or Public Storage Ticket at all times. We may direct you at any time at the Event to produce a valid Parking Ticket or Public Storage Ticket. We accept no liability for any property returned that is honestly returned by us to the bearer of a Parking Ticket or Public Storage Ticket.
4. You cannot sell, on-sell, or exchange for fee your Vehicle Accreditation, Parking Ticket or Public Storage Ticket without the prior written consent of AGPC.
5. Your Vehicle Accreditation or Parking Ticket entitles you to park your Vehicle in the specified parking area on the specified day or days of the Event. Unless otherwise signed or advised by AGPC, parking areas at the Event are open from 6.00 am until 7.30 pm. You must remove your Vehicle from parking areas by no later than 7.30 pm on each day of the Event unless you receive specific authorisation from AGPC in writing.
6. In the parking areas, you must:
  - a. comply with all directions issued by AGPC staff and contractors and Dorna Sports S.L., including any signs or verbal instructions;
  - b. park your Vehicle within the boundaries of any parking area or parking bay as directed; and
  - c. not cause any obstruction to other vehicles, pedestrians, road paths or any other unreasonable obstruction, andif you fail to comply you may be directed to leave or remove your Vehicle from the parking areas.
7. The fee for the Parking Ticket will not be refunded under any circumstances. All fees are inclusive of GST. You may obtain a tax invoice for your payment of parking fees via email to [ticketing@grandprix.com.au](mailto:ticketing@grandprix.com.au) and providing your Parking Ticket or other proof of payment acceptable to AGPC.

8. You may be charged additional fees if you leave your Vehicle or personal property at a parking area outside the period specified on your Vehicle Accreditation, Parking Ticket or Public Storage Ticket.
9. **Your Vehicle may also be towed at your / the owner's expense if:**
  - a. you breach these Parking Conditions;
  - b. the Vehicle is causing an obstruction, inappropriately parked or for any other reasonable cause (in AGPC's sole and absolute discretion);
  - c. the Vehicle is parked in a parking area limited to particular Vehicle Accreditations and the relevant Vehicle Accreditation is not displayed; or
  - d. remains in a parking area after 7.00 pm on the Sunday of the Event.

**AGPC and associated entities will not be liable for any damage incurred to your Vehicle as a result of removal in contravention of these Parking Conditions.**
10. You, to the extent permitted by law, hereby exclude, release and forever discharge us from all liability for claims, loss, damage, costs or expenses (whether arising under statute, from negligence, personal injury, death, property damage, infringement of third party rights, vandalism or other criminal activities or otherwise) arising from or connected with you and your Vehicle's entry to, exit from and presence at parking areas at the Event.
11. You, to the extent permitted by law, hereby indemnify us in respect of any claim made against, or expenses incurred by, any of us as a consequence of, in relation to, or in any way arising from you and your Vehicle's entry to, exit from and presence at parking areas at the Event.
12. Under these conditions:
  - a. **Vehicle** means any car, van, motorcycle or other vehicle under the *Road Safety Act 1986* (Vic); and
  - b. "**we**", "**us**" and "**our**" means the AGPC, the Crown in right of the State of Victoria, the Minister administering the *Australian Grands Prix Act 1994* (Vic), Dorna Sports S.L., the Fédération Internationale de Motocyclisme, Dorna Worldwide S.L., International Events Services S.L., Externpro S.L., Fontetes Motor S.L., Promomedia S.L.U, Promotor Les Comes Special Events S.L., PI Circuit Pty Ltd, PI Graydens Pty Ltd, PI Sunrise-McGuigan Pty Ltd, PI Visitor Centre Pty Ltd, PI Operations Pty Ltd, Linfox Property Group Pty Ltd, Fox Group Holdings Pty Ltd, International Road Racing Teams Association, Motorcycling Australia Limited, Motorcycling Victoria, Integrated Event Delivery Management Pty Ltd, teams, service companies, national and international officials, race direction, clerks of the course, sporting technical stewards, MotoGP Medical Team, MotoGP Health Center, timekeepers, marshals, sponsors, TV broadcasters, all accredited media, all VIP guests from the above mentioned bodies and all other persons involved in the conduct, promotion and organisation of the Event and parking areas at or related to the Event, and their respective personnel, affiliates, successors and assigns.
